




This chart shows the total general purpose revenue Pioneer Union Elementary School District expects to receive in the coming year from all sources.

Of the \$823204 in LCFF Funds, \$174525 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



- 1.1 Purchase and Maintain Aeries Analytics 100% of parents using aeries to enroll students, monitor grades, and communicate with teachers and is effective
- 1.2 Maintain Credential Teacher(s) for class size reduction- Class size reduction possible due to maintaining credentialed teachers effectively
- 1.3 Professional Development for Faculty and Staff- Faculty and Staff self reported pd increased teacher capacity and strategies could be implemented to maximize student outcomes
- 1.4 Hiring and maintaining preschool/TK teacher- This action was effective as measured by the increase in IReady scores from in ELA from 16% of student at or above grade level to 24% in 2023-2024
- 1.5 Hire and Maintain Paraprofessionals- We have four paraprofessionals who support students to implement grade level curriculum in small groups within the multi grade classroom which is proven to be effective by the increase in ELA scores by 3.45%, and in Math an increase of 1.67% in IReady scores from the baseline.
- 1.6 Student Incentives for PBIS and Attendance- Our chronic absenteeism has decreased by 36.7 from 52.8 to 16.1

- 1.7 Technology ITS contract to house data and provide IT support- contract is necessary to keep our school functioning
- 1.8 Tutoring and Intervention afterschool for unduplicated pupils and all students- Students completing homework has increased across grade levels as indicated by teacher input and proven to be effective by the increase in ELA scores by 3.45%, and in Math an increase of 1.67% in IReady scores from the baseline.
- 1.9 Supplemental Curriculums and Programs- I-Ready, IXL, Vocabulary A to Z, Navigate 360 etc. were purchased or subscriptions renewed and by proven to be effective by the increase in ELA scores by 3.45%, and in Math an increase of 1.67% in IReady scores from the baseline.
- 1.10 Purchase technology- devices were purchased for students to replace damaged or outdated devices
- 1.11 Paraprofessional Professional Development- Paraprofessionals had 10 days of pd and self reported the positive benefits in addition to the student benefit which is proven to be effective by the increase in ELA scores by 3.45%, and in Math an increase of 1.67% in IReady scores from the baseline.

- 1.3 Professional Development for Faculty and Staff- We would like to add an self survey metric for faculty and staff measuring training effectiveness and implementation after all PD opportunities
- 1.4 Hiring and maintaining preschool/TK teacher- We would like add a metric of TK teacher participation in preschool/tk/k training opportunities

- 2.3 Conduct Fit survey- N/A because we do not have our own school facility yet
- 2.4 Provide transportation- By providing transportation to and from school we reduced our chronic absenteeism by 17.4%
- 2.5 Providing all students with meals- Very effective and 100% of our students have meals at school.
- 2.6 Parent Liaison communicate with all families regarding attendance and coordination of all services- Very effective because we have a high number of parents who reach out directly to the liaison and she provides parents with information and schedules and organizes the parent advisory meetings.

# **Plan Summary [2024-25]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Pioneer Union Elementary School District (PUESD) was created in 1962 as a 26 acre rural campus in Berry Creek. At one time there were two schools in the district but due to declining enrollment in the 1980's Bald Rock School was closed leaving Berry Creek Elementary School as the only school in the district. The district is also supported by Butte County Office of Education which operates the after school program. On September 8, 2020 the North Complex Fire destroyed the Berry Creek community including the school. Thirty-three of our thirty-five families lost their homes. All of our School Board members lost their homes as well. Eight of twelve staff also lost their homes. Most of our students did not have time to take many things when they evacuated. Many of our students were living in motels, trailers, motorhomes or with relatives. Due to our students in distance learning we were able to communicate with our families and provide needed assistance immediately. Due to the loss of our school all our students and families were considered homeless for the 2020-2021 school year. Our families were scattered all over the United States. Due to the Campfire in Paradise two years earlier the infrastructure in the county was prepared and jumped into action to help our families!

At the time of the fire we had fifty-six students enrolled in our school with all students in distance learning. In October we started in-person instruction following the Covid-19 school safety guidelines. Over the last two years our enrollment has lowered to 30 students and we moved from Ophir Elementary School in Oroville to Bangor Elementary School in Bangor. Our classes are divided into TK-2, 3-5 and 6-8. Based on our Calpads data 94% of our students receive free and reduced lunch, 7% are English Language Learners and we have two foster students attending our school.

The Berry Creek families and school staff believe in educating the whole child. The staff and the Board of Trustees take pride in helping children to grow academically, socially, and emotionally. In adopting new curriculum which is written to incorporate the California State Standards all stakeholders believe this will prepare our students to be divergent learners in the 21st century. We expect students to be actively involved, enthusiastic about, and responsible for their own learning. We strive to produce a safe and challenging environment where students develop competitive and cooperative skills with a high sense of self-respect.

## **Reflections: Annual Performance**

Upon analyzing the data from the California Dashboard, Berry Creek Elementary qualifies for Comprehensive Support and Improvement (CSI) designation due to red indicators in Suspension rates. Specifically, 21.2% of all students, 23.5% of the homeless population, and 21.2% of socioeconomically disadvantaged students were suspended. Addressing suspension rates is a primary focus of our Local Control and Accountability Plan (LCAP). Additionally, there has been a decline of 46 points in ELA scores and 40 points in Math scores, both of which are addressed in our LCAP strategy. To bridge these academic gaps, it is imperative to strategically identify the essential skills and concepts lacking in our students' learning and design academic programs that precisely target these areas with surgical precision (Johnson & Smith, 2021).
